

MAFFRA GOLF CLUB (MGC)
STANDARD CONDITIONS

- *Only financial playing members with a current Golf Link number and Golf Australia (GA) handicap are eligible to compete in an event.*
- *Professionals with a current GA handicap may play in all handicap competitions but are ineligible for Scratch events.*
- ***Entry to an event:** Each player must be booked into the MGC Bookings portal located on the clubs Web site. Note: only players that are pre booked can register to enter an event.*
- *Before teeing off each player must register into the event at the Kiosk in the starters box. Once your name is registered in the Tier 3 event Kiosk you will be deemed to have entered into the competition and expected to pay the entry fee and will be handicapped.*
- *If you're unable to play on the day it is the players responsible to delete the booking or notify the club well before you're allotted tee time to enable the club to delete the booking.*
- *On completion of the round each player is expected to enter their score into the Tier 3 Kiosk in the clubrooms, scores not entered will be deemed to be "No Score Not Approved" Note: 5 of these in the last 20 rounds will suspend the players handicap.*
- *Competition payment Options;*
 - *Preferred payment option is by Credit/Debit card; If the bar is unattended and you wish to pay by card this can be done after 9 holes or on completion of your round when the bar is open.*
 - *Arrangements can be made for you to pay by direct debit.*
 - *Cash monies can be placed in an envelope and posted in the Fees box in the starters box or paid at the bar with your name, date and amount paid noted on the envelope.*
- *It is the player's responsibility to ascertain their correct playing handicap. This can be obtained from the Tier 3 Kiosk screen in the starter's box or on the official GA handicap site.*
- *Competitors must be ready to start at the appointed time. Only on special circumstances approved by the Match Committee, may competitors be permitted to start at a later time.*
- *The Match Committee reserves the right to limit the number of entries.*
- *All competitions shall be played in accordance with the Rules of Golf as adopted by the Royal & Ancient Club of St Andrews, subject to local rules that are in force on the course.*
- *All competitors are requested to observe the guidelines in Rule – 1 "The Game, Player Conduct and the Rules" and are reminded that the committee may disqualify any competitor for a serious breach of the rules (Rule 1.3b)*
- *Any dispute or protest will be decided by the Match Committee whose decision will be final.*
- *The Match Committee to make all arrangements, and to have full power to alter the conditions, should they deem it desirable and shall have the right to refuse the entry of any person without being required to give reason for such refusal.*
- *All competitors must use a golf ball & equipment as approved by the R & A.*

- *Players are reminded to keep up with the group in front.*
- *Motorised carts are permissible but misuse or dangerous actions are not allowed refer to the Clubs “Motorised cart policy”.*
- *Premium golf balls e.g., Titleist DTL balls are only provided to financial members of the MGC.*
- *All competitors are required to comply with MGC dress regulations.*
- *All players are requested to carry sand buckets, repair divots & pug marks.*
- *Players are requested only to use Mobile phones in an emergency on course otherwise they should be turned off.*
- *CADDIES: Professionals are not permitted to caddie.*
- *BYO alcohol is not permitted.*
- *Golf activities can be inherently dangerous. All competitors understand that they are exposed to certain risks during golf activities & that accidents can & often do happen. Acceptance of entry releases MGC from all claims that entrants may have or may have had but for this release arising from or in connection with participation and indemnifies and will keep indemnified MGC in respect of any claim by any person arising as a result of or in connection with participation in any golf activity. “Refer to the” (Inclement Weather Policy)*
- *MGC has a comprehensive public liability cover, however this does not extend to personal accident insurance for each competitor.*
- *Damage or personal injury caused by people using the practice facilities including the neighboring houses and road users will not be covered by the MGC.*
- *MGC Standard Conditions of Entry relating to Drugs Personal Risk & Medical Conditions, Heat, Pace of Play & Privacy will apply to all events.*
- *The Match Committee may provide in the condition of a competition (Rule 5.7b) that, in potentially dangerous situations, play shall be discontinued immediately following a suspension of play by the Match Committee. If a player fails to discontinue play immediately, they may be disqualified unless circumstances warrant waiving such penalty as provided in Rule 5.7b.*
- *Blatant disregard for the MGC Standard Condition may result in disciplinary action enforced by the current committee.*
